### INFORMATION FOR COMPETING ABROAD ON A DOMESTIC LICENCE

Please be advised that from January 1st 2016 the FIA have amended the International Sporting Code to allow foreign participation in National Events without the requirement to hold an International licence. This does not apply for CIK/FIA International events. In summary the following points must be considered:

- You must have the approval of the foreign ASN to compete in a National event.
- You will not have any insurance coverage from Karting Australia when overseas. You need to check with the organiser to confirm what coverage they have in place and/or arrange your own insurance being mindful of the level of coverage and its inclusions/exclusions such as transportation costs if you need to be transported back to Australia, level of coverage, imposed limits of coverage and all other considerations
- You will not be able to score points in the classification of the championship, cup, trophy, challenge or series.

You should make yourself familiar with all regulations of the competition, the International Sporting Code and in particular the relevant articles of the International Sporting Code as follows:

**2.3.2** Except as provided for below, a *National Competition* is open only to *Competitors* and *Drivers* holding a *Licence* issued by the **ASN of the country in which that *Competition* takes place.**

**2.3.4** A *National Competition* may, at the discretion of the authorising **ASN**, accept the participation of licence-holders **from other ASNs.**

**2.3.5** Any *National Competition* must be listed on the national calendar of the authorising **ASN.**

**2.3.6** *National Championship*, cup, trophy, challenge or series open to foreign licence-holders

**2.3.6.a** If the *National Competition* forms part of a *National Championship*, cup, trophy, challenge or series, *Competitors* and *Drivers* who are foreign licence-holders will not be eligible to score points in the classification of the said *Championship*, cup, trophy, challenge or series. The allocation of points in the ranking of the said championship, cup, trophy, challenge or series must be done without taking the *Competitors* and *Drivers* who are foreign licence-holders into account.
