Race numbers listed in Appendix 1 of the Series Sporting Regulations are allocated to the drivers who got approval from IKD to secure their race number. The Race/Competition Secretary of the Meeting reserves the right to allocate/change Competition numbers in accordance with the Competition Rules, Chapter 1, Rule 11 j) and subject to the provisions of the 2019 Rotax Pro Tour National Series Sporting Regulations. 4. TECHNICAL REQUIREMENTS

1. SCRUTINEERING
Scrutineering for this Meeting will be in accordance with the provisions of the Technical Rules, Chapter 6 of the Rules. In accordance with the provisions of the Technical Rules, Chapter 6 of the 2019 KA Manual, each Kart shall have affixed to it a correct scrutineering sticker or identifying mark supplied for the Meeting. This signifies that the Driver has confirmed their entry for the Meeting and completed a Scrutineering Form relevant to the Entry. As from 26/01/2019, the Grid Marshal / Scrutineers shall not permit any Kart that does not display a correct scrutineering sticker or identifying mark to Practice, Qualify or Race.
2. ENGINE SEALING AND CHASSIS TAGGING
Each engine and chassis must be sealed and tagged in accordance with the provisions of Technical Rules, Chapter 6.
3. TYRE POOLING & TYRE MARKING
Tyre Pooling Will Not be used at this Meeting.
All Competitors are required to have Barcoded Tyres for this Meeting. <u>Race Tyres must be presented for scanning before Qualifying at the appropriate time.</u> Tyre scanning will be conducted between <u>12:00pm and 2:00pm</u> on Friday, 25 January 2019 All Tyres must have white barcodes only.
If the Track is declared Wet, Competitors will be required to present their Wet Weather Tyres for scanning as directed by Officials.

5. CIRCUIT SPECIFIC REQUIREMENTS

1. MEDICAL SERVICES

2. KART RETRIEVAL
Pit Crew with trolleys will not be given access to the Track during Qualifying and Racing. Retrieval is at the discretion of the Clerk of the Course. Pit Crew must only enter the Track when permitted by the Grid Marshal or the Clerk of the Course and then only if wearing a HIGH VISIBILITY SAFETY VEST on the upper torso. Karts can be retrieved via the outgrid.
3. SECURITY
Security will be provided from Thursday 24rd January 2019 to end of Meeting – security will be onsite from 7pm each day.
4. TRADE AREAS
