Good Afternoon,

Firstly, **thank you** to all of you who have joined in the first two webinars. We have the Northern Territory, South Australia and Tasmania first up tonight followed by Western Australia at 7:00pm WA time. By the time we have finished the 4 webinars, it looks like we will have had almost 200 Club and State association representatives on line with us over three nights. WELL DONE TEAM.

Today we are releasing a simple "**Do's, Don'ts and Tips**" booklet to summarise the 11 most important things that need to be done to plan and implement a **STAGE 1** <u>COVIDSafe</u> Social Karting Activity at your Clubs.

Stage 1 is really pretty simple to do. It involves only these areas of the Club: the Paddock where you must park up allowing plenty of space between other karters who are in attendance, the Out Grid, In Grid, Race Track and Toilets.

We estimate that Clubs probably have around 4 weeks before **Stage 2** can start which gives everyone time to do the facilities assessment and to create your **COVIDSafe Club Action Plan** (that takes in all of the Club's facilities that are used for Competition Karting. It may be 4 or so weeks away, but I recommend that you **print out the assessment form** and get started on it sooner rather than later.

We mentioned last night that we would also be releasing a <u>COVIDSafe Club Checklist – Stage 1</u> form today. This online form should be completed and submitted at the time that you submit your first set of **Stage 1 Supplementary Regulations**. It is largely a "Yes" "No" form that is simply completed but it tells Karting Australia and our Member States that you have put the required COVID-19 Control and prevention measures in place for your Stage 1 COVIDSafe Karting Activity.
